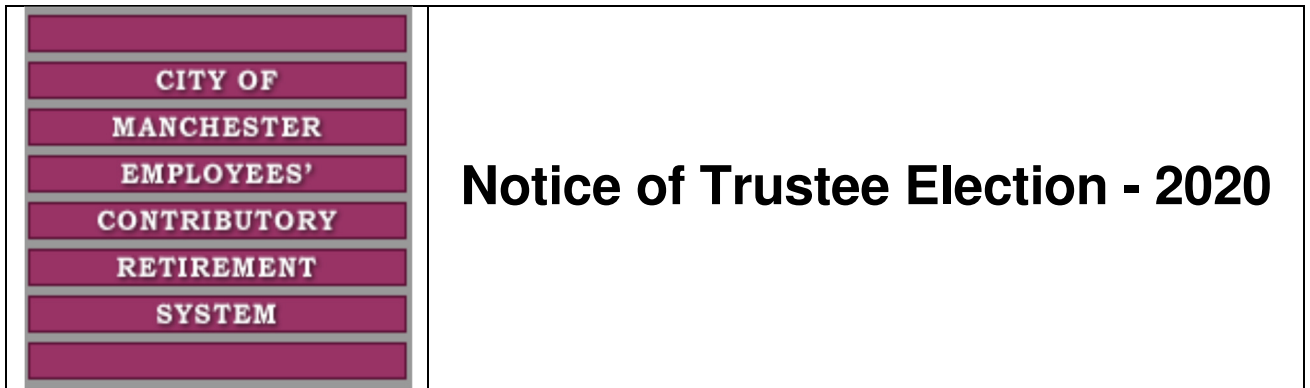
Anyone wishing to run for either the 3 year term or the 2 year term of Employee Representative can obtain a Declaration of Candidacy form at the City Clerks Office during the filing period of October 26 – October 30, 2020. You must be a current employee of the City of Manchester and be a member of the Contributory Retirement System.

The election will be held Thursday, December 10, 2020 from 10:00 am to 6:00 pm at the JFK Coliseum warm-up room, and the City Hall Walter A. Stiles Conference Room. Please see below to find out where your department will be voting.

Any member who is absent from the City of Manchester on election day, or who cannot appear in public on election day because of religious observance, or who is unable to vote in person by reason of physical disability may vote absentee at the Retirement Board election.
